


ASSET Changes Implemented

The following changes to ASSET were implemented on July 17, 2019:

Title 3 Fund Source Consolidation

When adding services for Title 3 program (Wagner-Peyser checked) the allowable fund sources are now limited to:

- Wagner-Peyser
- RESEA
- Other
- MSFW
- JVSG (previously "Veterans")



Recording Select Services for Reportable Individuals without Participation

To meet updated guidance from ETA, we have relaxed requirements on Manage Programs (Title 1 Adult, Youth, Dislocated Worker, Title 3 Wagner-Peyser and JVSG) to allow generation of a Registration Date and entry of self/informational only services for a customer without completing the required fields in Manage Programs. These services can be financed by any fund source.

If the 'Reportable Individual Only' checkbox is checked the only required fields are Registration Date and Program Begin Date:
