ASSET Changes Implemented

The following changes to ASSET were implemented on October 1, 2019:

• Removed National Career Readiness Certification (NCRC) services

NCRC Certification service is no longer being provided. 'National Career Readiness Certification' service no longer appears as a service that can be associated to a customer.

• Removed 'Last Client Self-Service Date' (Manage Customer – Contact Details tab).

'Last Client Self-Service Date' was not calculating properly and since it is no longer used it was removed. Staff can determine client's last self-service date by checking the last Title 3 Online Self-Services and Informational Activities service recorded on Service Summary screen.

• Fixed 'Updated Date' (Manage Assessments)

Corrected an issue where 'Updated Date' on Manage Assessments screen was not displaying the correct date.

• Fixed Column Sorting (Service Summary)

Corrected an issue where sorting columns on the Service Summary caused some Program Participation information to not display correctly.

• Fixed Toggling Reportable Individual Only to Youth (Manage Programs)

Corrected an issue where unchecking 'Reportable Individual Only' disabled the 'Basic Skills Deficient' radio button, preventing addition of Youth Program screen.

• RESEA – Updated holiday list in ASSET(this is done yearly).

RESEA session creation cannot happen on the day of a holiday.

• RESEA – Updated roster column from Work Search Review to UI Eligibility Review.
