Title 3 – JVSG program changes

- The JVSG Eligibility section will save the correct values at the time of program creation. Updates to the Customer Record will not update the values displayed in the JVSG Eligibility section of the JVSG Program Record. ASSET Administrators will now be able to edit the JVSG Eligibility section. *This only impacts JVSG programs created after the deploy and does not impact current/active or exited JVSG episodes.*
- The "Entitled to VA compensation due to a service-connected disability" field within the JVSG Eligibility section will have the correct values going forward. *This only impacts JVSG programs created after the deploy and does not impact current/active or exited JVSG episodes.*
 - If the Customer Record indicates the participant is "Not Disabled" in the "Service-Connected Disability" field, the corresponding field within the JVSG Eligibility section will be marked "No."
 - If the Customer Record contains any other selection in the "Service-Connected Disability" field, the corresponding field within the JVSG Eligibility will be marked "Yes."
 - If the Customer Record does not contain any response in the "Service-Connected Disability" field, the corresponding field within the JVSG Eligibility section will not have a response selected.
