Changes to ASSET Alerts and Notifications

- > Alerts are items that need some action from you or the participant.
- > Notifications are informational items that you may want to be aware of, but don't need to take any action on.
- A search/filtering option was added so that staff can view Alerts & Notifications from a specific date range, by alert/notification type, for specific WDA or all WDAs, by PIN or customer's last name:

CEPT Alerts and Notifications

All existing CEPT Alerts and Notifications can now be managed in ASSET.

- 1. Alerts
 - Services associated with an employment plan that were planned but never started Hyperlink on the PIN number navigates to the Services Page in ASSET
 - Action steps associated with a plan that are overdue Hyperlink on the PIN number navigates to the action steps widget in CEPT
 - Pending Self-sufficiency calculations where the participant has not been notified—
 Hyperlink on the PIN number navigates to the Self-sufficiency calculation widget in CEPT

Alerts will disappear from your list once the item has been addressed.

- 2. Notifications
 - Participant has shared a budget with staff Hyperlink on the PIN number navigates to the Budget widget in CEPT
 - Participant has signed off on an employment plan -- Hyperlink on the PIN number navigates to the Employment Plan widget in CEPT
 - Participant has shared a Self-sufficiency calculation -- Hyperlink on the PIN number navigates to the Self-sufficiency calculation widget in CEPT
 - Participant has accepted or rejected a Self-sufficiency calculation -- Hyperlink on the PIN number navigates to the Selfsufficiency calculation widget in CEPT
