ASSET Changes – Will be deployed on March 24th, 2025

MSFW questions updated on JCW and ASSET for the RESEA Assessment (Question 47 to 47b)

- New questions 47 to 47b are updated/added and are as follows
 - 47. In the last year (12 months), have you worked in any type of agriculture, even if for a short period of time or as a side job?
 - 47a. Were you hired to work seasonally in that agriculture job – so, for only part of the year?
 - 47b. Did you leave your primary residence and live somewhere else temporarily while you were working this job?
- Each consecutive question only shows up if the previous one is answered as "Yes" on JCW
- For all completed assessments "Eligible Migrant and Seasonal Farmworker Status" field on the Programs tab will populate as "No"
- If question 47 or 47a is answered as "No" then the "Migrant Seasonal Farmworker" dropdown on Title 3 Program tab is populated as "No"
- When question 47b is answered as "Yes" then the "Migrant Seasonal Farmworker" dropdown on Title 3 Program tab is populated as "Migrant"
- If question 47b is answered as "No" then the "Migrant Seasonal Farmworker" dropdown on Title 3 Program tab is populated as "Seasonal Farmworker"
- All these changes are future only, all the past data will be unchanged.
