



CTE Incentive Grants 2024-25 Approved Certifications List April 15, 2024

This list includes the industry-recognized certifications approved for the 2024-25 academic year that are eligible for the Career and Technical Education (CTE) Incentive Grants program authorized by Wisconsin Statutes 106.273. Developed by the Department of Workforce Development (DWD), with input from the Department of Public Instruction (DPI) and Wisconsin Technical College System Office (WTCS), the certifications list considers the recognition and validity of the certifying agency, student accessibility, and programmatic rigor.

The list:

- Is organized into the five certification categories.
- Provides the names of the certification entities and certifications approved for the 2024-25 academic year.
- Provides the documentation requirements for Class of 2025 claims.

The list is revised annually to ensure relevance to current industry needs and in accordance with program goals and requirements. District and school staff are to use the most recent version published on the DWD CTE web page for documentation requirements. The version date will be posted at the top of the published document.

School districts will benefit from having all staff members assigned roles with the CTE incentive grants attend the training provided for the various tasks required to submit high quality and relevant claims. How to Use the Annual CTE Approved Certifications Lists

Users may need to refer to previous annual lists to confirm that the certifications earned were approved for the year in which they were earned but must use the 2024-25 list to know the documentation requirements for claims submitted with the Class of 2025. Lists in effect for previous academic years are available on the CTE web site.

- 1. Use the list from the year the certification was earned to confirm that the certification was approved for the year that it was earned.
- 2. Regardless of the year the certification was earned, locate the information in the last column on the table in this document to identify the documentation required to support the Class of 2025 claim. If the certification appears on the list for the year that it was earned but is not on this list, it was probably discontinued but may still be eligible. If you have questions, contact DETCTEGrants@dwd.wisconsin.gov for guidance prior to creating a claim.
- 3. Ensure that your claim and documentation meet the requirements indicated for the specific certification.
- 4. Only the student personally identifiable information (PII) required to process the claim should be visible on unofficial transcripts and other documents. Districts are responsible for adhering to DPI's privacy policy by redacting unnecessary PII.





The Updated List

There are no major changes from the previous year's list.

The three new career clusters for Youth Apprenticeship have been added.

Notable changes in details for some certifications appear in the table as blue text.

Tips to Improve Claim Quality and Reduce the Need for Corrections

- Add deadlines to your electronic calendar and give plenty of time for submitting and correcting claims.
- Attend the training and use the resources provided.
- Gather, prepare, and submit the required documents. Do not submit alternative documents.
- Contact <u>DETCTEGrants@dwd.wisconsin.gov</u> with questions and/or to notify the program lead of changes in district/school contact information.
- Submit a separate student completion award claim for each of the certifications that may
 make the student eligible for a student completion award and always submit them under
 Business and Industry even if using a college transcript to support the claim.
- Proactively manage your use of Microsoft Office Specialist licenses, available free or purchased, at the district level and be consistent across all of the district's schools. Submit claims only if they were earned through licenses that your district purchased.
- Only one certification per student can be approved for a district incentive grant. Please
 consider limiting the number of incentive grant claims to two per student except in cases
 of student completion awards.
- If you submit unofficial college transcripts for WTCS claims, remember to redact all student personally identifiable information not necessary for us to process the claim in accordance with DPI guidance.

If you choose to redact by crossing out information, double check that your method made the printed information non-visible **on the scanned document**. In some cases, the scanning process has created an electronic document in which the inked cross-outs become translucent, allowing the printed information underneath to be discerned.

The district must submit a separate claim for each SCA certification that a student earned so that students' SCA eligibility can be determined for each potential award.

EMR and EMT claims submitted under a category other than Business and Industry will not be eligible. Districts MUST submit every SCA claim under Business and Industry and select the correct certification entity.
