for District Incentive Grants and Student Completion Awards  
March 6, 2025

This list includes the industry-recognized certifications approved for the 2025-26 academic year that are eligible for the Career and Technical Education (CTE) Incentive Grants program authorized by Wisconsin statutes 106.273.

The list:

- Is organized into the five certification categories.
- Provides the names of the certification entities and certifications approved for the 2025-26 academic year.
- Provides the documentation requirements for class of 2026 district incentive grant claims and student completion award claims.

The list is revised annually to ensure relevance to current industry needs and to align with program goals and requirements. District and school staff should use the most recent version published on the Department of Workforce Development (DWD) CTE web page for documentation requirements. The version date will be posted at the top of the published document.

School districts will benefit from having all staff members assigned roles with the CTE incentive grants attend the training provided for the various tasks required to submit high quality and relevant claims. Training is available through the Training & Resources tab on the DWD [CTE Incentive Grants website](#).

## How to Use the Lists

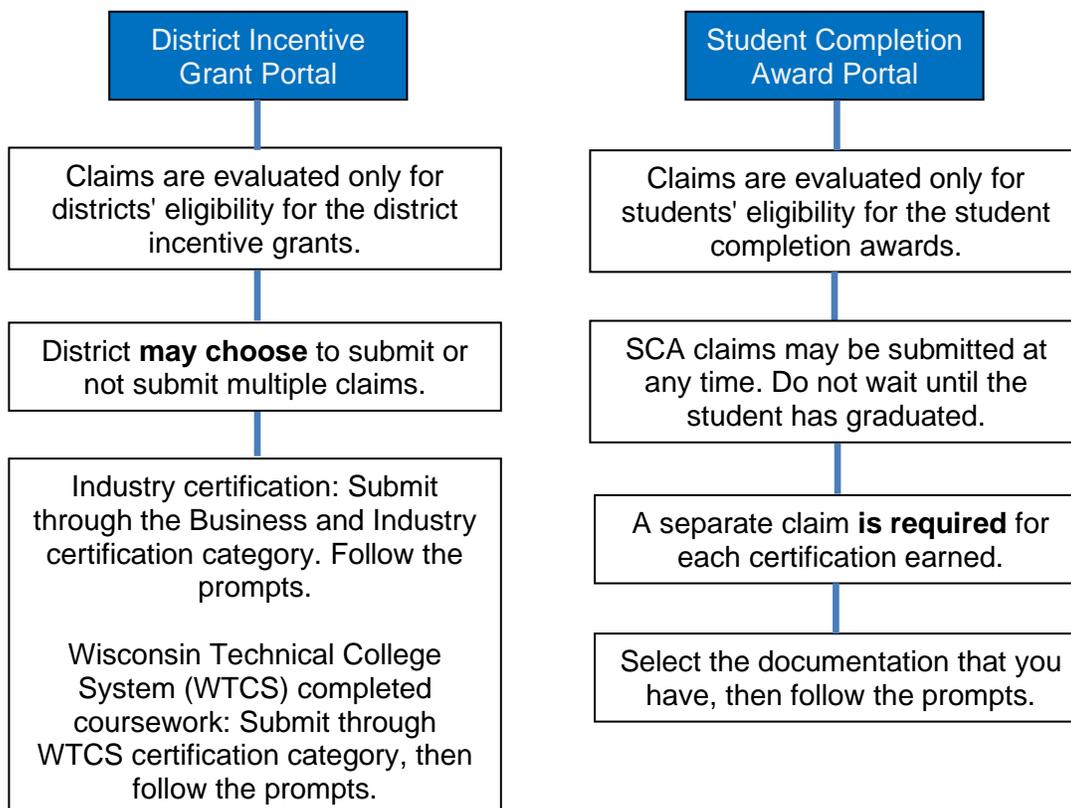
Users may need to refer to previous annual lists to confirm that the certifications earned were approved **for the year they were earned**. The current list must be used to know the documentation requirements for claims submitted with the class of 2026. Lists from previous academic years are available on the CTE website.

1. Use the list from the year the certification was earned to confirm the certification was approved for the year it was earned.
2. Regardless of the year the certification was earned, locate the information in the last column on the table in this document to identify the documentation required to support the 2025-26 claim. If the certification appears on the list for the year that it was earned but is not on this list, it was probably discontinued but may still be eligible based on the year in which it was earned. 3. Ensure that your claim and documentation meet the requirements indicated for the specific certification.
4. Only the student personally identifiable information (PII) required to process the claim should be visible on unofficial transcripts and other documents. Districts are responsible for adhering to DPI's privacy policy.

## The Updated List

No major changes to specific certifications have been made. Some minor changes were made to the list. Training on submitting claims for district incentive grants and student completion awards is available on the DWD CTE webpage. (Later in 2025, applications will be taken from school districts for new certifications to be added to the next year's list.)

The list has been reorganized because student completion award (SCA) claims are now being submitted through the SCA-specific claim portal. The following changes were made:



## Tips to Improve Claim Quality and Reduce Corrections

- Add deadlines to your electronic calendar and give plenty of time for submitting and correcting claims.
- Attend the training and use the resources provided.
- Gather, prepare, and submit the required documents; do not submit alternative documents.
- Contact [DETCTEGrants@dwd.wisconsin.gov](mailto:DETCTEGrants@dwd.wisconsin.gov) with questions or to update the program lead about changes in district or school contact information.
- Submit a separate student completion award claim for each of the certifications that may make the student eligible for a student completion award. These are submitted in the SCA portal and are used solely for evaluating a student's eligibility for the awards.

- Only one claim per student can be approved for a district incentive grant. Please consider limiting the number of **district incentive grant claims** to two per student.
- Proactively manage your use of Microsoft Office Specialist licenses (free vs. purchased) **at the district level and be consistent across all district schools**. Submit claims only if the certifications were earned through licenses that your district purchased from Certiport.
- If you submit unofficial college transcripts for WTCS claims, remember to provide program numbers and names, highlight required courses when a transcript wasn't printed with the certificate or program name, and adhere to the Department of Public Instruction's (DPI) student data privacy rules.
