Dear Mr. Zillmer:

Maslow Media Group, Inc. (the "Company") submits this letter to you to satisfy any obligation that may exist under the federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. (the "WARN Act") and Wis. Stat. § 109.07 and Wis. Admin. Code DWD 279 et seq. ("WI-WARN"). If no obligations exist under the WARN Act and WI-WARN, this letter is being provided to you voluntarily.

The Company employs employees and temporary employees who are assigned to provide services to Al Jazeera America, LLC ("AJAM"). One employee or temporary employee is based at the following location: [1] employee at [REDACTED] (home address) (collectively, the "Employees").

AJAM will be permanently closing down its entire operations in the United States on or about April 30, 2016. Accordingly, all Employees will be terminated and such terminations are expected to begin sixty (60) days following the date of this letter or within fourteen (14) days thereafter. Such terminations will be permanent and Employees have no bumping or recall rights.

Exhibit A lists the job titles of positions to be affected and the number of affected Employees in each job title.


