In accordance with the Worker Adjustment and Retraining Notification Act ("WARN Act") and applicable state law, we are providing advance written notice to those employees affected by the decision as well as you. The name and telephone number of the Company official to contact for more information is as follows: Gail Monreal, Vice President HR Stores/DC, 414-212-6741.

The date of the first separation from employment is anticipated to be June 5, 2018 and is expected to take several months. A spreadsheet with the names, addresses, job titles and number of employees in each affected position is attached hereto. No bumping rights exist. No employees are covered by a collective bargaining agreement. Other information related to these actions will be maintained at the Company offices at 331 W. Wisconsin Ave. Milwaukee, WI 53203. Ms. Monreal may be contacted for further additional information. The timetable for the closing is based on the best information available, although it is subject to change as we evaluate our options, including option of selling the business and continuing as a going concern and subject to any actions of the bankruptcy court. Specifically, on or about February 4, 2018, the Company filed for Chapter 11 protection under the Bankruptcy Code and since that date has been actively engaged in efforts to reorganize the business or sell the business.
