Announcement of Planned Action**

To Whom it May Concern:

I am writing on behalf of the entities below, doing business as Home Owners Bargain Outlet (“HOBO”) to give you notice that HOBO is pursuing a sale of its business operations and facilities, but due to current economic circumstances, is concurrently preparing to conduct an orderly liquidation and wind down of its operations. As a result, absent entering into an agreement to sell to a new operator, HOBO anticipates closing its doors at the following facilities by December 31, 2018.

Names and addresses of facilities expected to close and current number of employees at such facilities who are expected to be terminated in connection with such closings:

These closures will result in employment losses for all employees. Such employees have been notified of these closures and that the facilities will close in their entirety and that the employment losses will be permanent. We expect to begin terminating employees at these facilities beginning on December 20, 2018, and anticipate completing all terminations on or before December 31, 2018.

The attached is a list of the job positions by entity/location and number of individuals within each of the positions who will be affected by the closures.

There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of these closures. HOBO does not have union employees.
