RE: Notice of Business Closing/WARN Notice

Dear Members of the Dislocated Worker Unit:

Motor Castings Company will be permanently closing its facility at 1323 S. 65th Street, Milwaukee, WI 53214. The closure has been prompted by the company's decision to relocate the product line manufactured at that location.

This action is expected to result in the permanent elimination of 113 employees – 13 salary and 100 hourly positions. The company expects to begin eliminating positions on May 20, 2019 and will continue in phases until complete closure on June 3, 2019.

The bargaining unit employees are represented by the United Steelworkers Union. The representative of this union is Juan Mercado, President of Local 1610. Juan Mercado is located at 1648 S. 3rd St., Milwaukee, Wisconsin 53214.

Attached is a list of job titles, number affected within in each job title, and the anticipated layoff date for the salaried and hourly workers. Please note that due to interplant bumping rights and/or early retirement elections, it is impossible to predict with certainty which represented employees will ultimately be affected or the exact order in which individual employees will be separated.

The company will ensure that employees will be paid all earned wages and agreed upon benefits at the time of their termination.
