RE: WARN NOTICE – GREEN BAY, WI – FACILITY LAYOFFS

This letter provides official notice to certain governmental units or officials that Schneider National Carriers, Inc. and its subsidiaries and affiliates (hereafter, the “Company”) will be permanently laying off 85 employees to include employees at the following Green Bay, WI locations; 3101 S. Packerland Drive, Green Bay, WI 54313, 1555 Glory Road, Green Bay, WI 54304, 911 Glory Road, Green Bay, WI 54304 and 2737 South Ridge Road, Green Bay, WI 54304.

The 85 impacted employees are less than 3% of the Company’s workforce in the Green Bay, Wisconsin area.

These layoffs are the result of the Company’s discontinuation of its First to Final Mile (“FTFM”) service offering. All such layoffs are anticipated to occur no later than September 30, 2019 any such FTFM employees subject to layoff before that date will receive wages and benefits through that date. Lists of job titles and the number of affected employees in each job classification is enclosed as a table below.

These layoffs are expected to be permanent. The employees who are being laid off are not represented by a union, and bumping rights are not available to them.
