Notice of Reduction in Force

To Whom it May Concern:

I am writing on behalf of Eastek Automated Circuit Technologies LLC ("EACT"), located at N90 W14739 Commerce Drive, Menomonee Falls, WI 53051 (the "Facility") to give notice that EACT expects to make some operational changes that will result in reduced workflow at the Facility. As a consequence, EACT will be substantially reducing its workforce at the Facility. The company anticipates that layoffs may start as early as March 31, 2020 and conclude by April 10, 2020, and will result in permanent layoff of 36 employees.

Such employees have been notified of these anticipated layoffs and that such layoffs will be permanent. The employees have also been provided with contact information for the Waukesha County representative of the Workforce Development Board.

The attached is a list of the job positions and number of individuals within each of the positions who will be affected by the closures.

EACT has no union employees. There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of these closures.

**WARN Act Notice
Reduction in Force and Related Employment Loss**

Dear [Employee]:

This letter is being issued in accordance with the Wisconsin Business Closing and Mass Layoff Law (the “*Wisconsin WARN Act*”) and, to the extent it may apply, the federal Worker Adjustment and Retraining Notification Act (“*WARN Act*”) in connection with the EACT facility located in Menomonee Falls, Wisconsin (the “*Facility*”).

Due to on-going economic challenges facing EACT, the company has determined that it must make some operational changes that will result in reduced workflow at the Facility. One consequence of the reduced workflow is that EACT will be reducing its workforce at the Facility. The company anticipates that layoffs may start as early as **March 31, 2020**. Unfortunately, these layoffs are anticipated to be permanent.

As a result, your employment with EACT is anticipated to end on or about, and no earlier than, March 31, 2020.

As you know, EACT has no union employees or collective bargaining representative. No employee has bumping rights.

In accordance with state law, we have notified the Wisconsin Department of Workforce Development (“*WDWD*”) of the proposed layoffs at EACT. For local assistance with employment and job training questions, services, and resources, you may contact the Waukesha County representative of WDWD at:
