Re: Notice of Potential Business Closing  
(Conditional WARN and WBCML Act Notice)

Dear Disclosed Worker Unit and Mr. Woodward:

This notice is provided pursuant to the Wisconsin Business Closing and Mass Layoff Law, Wis. Stat. § 109.07 (“WBCML”) and the Worker Adjustment and Retraining Notification Act, 29 U.S.C. §§ 2101 *et seq.* (“WARN”).

Marquis Yachts (the “Company”) anticipates that it will be temporarily closing its facility located at 790 Markham Drive, Pulaski, Wisconsin, effective March 1, 2020, and that this closure will last for an undetermined period of time. The Company has been actively engaged with a couple of potential buyers and other stakeholders to negotiate a sale of the Company with the goal to shore-up long-term financing to permit continued operations. As these ongoing efforts continue, the Company is working with its limited financial resources to continue operations up through March 1. Because it is unlikely that a sale of the Company will be finalized by March 1, 2020, we anticipate there will be a temporary shutdown beginning March 1, 2020 which will affect most, and potentially all, Company employees. However, if the company is able to close the sale of the business with a new buyer by February 29, 2020, then there will be no shut down.

This anticipated closure will impact all 344 employees at the Pulaski facility. The Company notified affected employees on 01/28/20. The notice was shorter than 60 days under the WARN Act and the WBCML Act because of unforeseen business circumstances, including the sudden decision by the previously anticipated buyer to withdraw from the purchase, and other unforeseeable business circumstances that were beyond the Company’s control including the Company’s inability to secure short-term financing to continue operations until the sale of the business is complete.
