Dear Ladies and Gentlemen:

I am counsel for Mickey's Linen. Please forward all communications and materials to me.

Although we do not believe WARN Act notification is required under the present circumstances, we are providing notice as set forth below on a voluntary basis. Due to unforeseen and drastic events unfolding as a result of the coronavirus pandemic, Mickey's Linen regrets to inform you that it has been forced to lay off employees in its Milwaukee, Wisconsin plant, 7400 Douglas Ave, Milwaukee, WI 53218, effective March 18, 2020, and continuing for several days, as needed. This is expected to be only temporary, until around the time that bans on the hospitality providers and other businesses serviced by the Company are lifted. The entire operation will not be closed, and will continue to be open, to the extent possible. No bumping rights exist in the affected positions. Recall of laid off employees is certainly anticipated, and shall be conducted in accordance with the terms of Collective Bargaining Agreements that cover employees.

Job titles of the affected positions, and the number of affected employees in each job title, include: Plant Production employees (33); Office and Administrative Staff (3); and Route Service Representatives (12). The Union representatives of affected employees, Tom Kanack,
