Re: Announcement of Planned Action

Dear Mr. Jackson and Mayor Rhodes-Conway,

I am writing on behalf of The Edgewater Management Company, LLC. to give you notice that there will be a mass layoff and reduction of work hours at The Edgewater's facility located at 1001 Wisconsin Place in Madison, WI on March 18, 2020. This mass layoff and reduction in work hours and rate of pay are expected to be temporary. Given this quickly changing pandemic and its impact on our business operations, it is not known when staff will be brought back to work from this mass layoff and when their hours will return to their previous schedule and rate.

All affected employees have been notified of their separation and/or effective dates and that their separation from employment or reduction in work hours and rate of pay will be temporary. Those employees are expected to be separated from employment or be subject to a reduction in work hours and rate of pay beginning on March 18, 2020, with all separations and reductions accomplished by April 1, 2020.
