Re: Notice of Reduction in Force at Hooters of America, LLC's Restaurants in Wisconsin

To whom it may concern:

This letter is to inform you that as a result of unforeseen business circumstances resulting from the sudden and unprecedented effects of the Coronavirus or Covid-19 outbreak ("Coronavirus") on our business, Hooters of America, LLC ("Hooters") will conduct layoffs at its corporate offices located at 1815 The Exchange SE, as well as its WI corporate owned restaurants located at:

("Restaurants"). We are providing this notice pursuant to the Federal Worker Adjustment and Retraining Notification ("WARN") Act, 29 U.S.C. § 2101 and Wisconsin Statute §109.07.

This is a partial reduction in workforce; not all HOA employees will be impacted. At this time, this action, based upon all available information, is anticipated to be permanent.

The first employee layoffs in connection with this action are expected to occur during the fourteen (14) day period beginning on March 16, 2020. We enclose a listing of the job titles of positions to be affected, and the number of affected employees in each job classification. Employees will be separated in accordance with the enclosed schedule. All affected employees have been or will be notified of their separation dates and that their separation from employment is anticipated to be permanent.

The affected employees at these restaurants are not represented by a union.

The affected employees do not have any bumping rights.

We apologize that we were unable to provide more advance notice of the action. We are providing this notice as soon as possible in light of the rapidly-developing events surrounding Coronavirus. The speed and vast reach of the coronavirus outbreak, as well as the numerous declarations of a state of emergency and directives at the Federal, State and local level for all individuals to: 1) remain/stay in place; 2) avoid all restaurants, bars, gyms and nightclubs; 3) avoid congregating in public in groups of 10 people or more; and 4) work remotely, were unforeseeable and are causing, and will continue to cause, among other things, a drastic impact on HOA's business, including but not limited to the closure of many Hooters restaurants, the cessation of all dine-in business operations in Hooters restaurants both nationally and within the State, substantial income and profit losses and an uncertain future such that the Company does not have alternative work to offer to its affected employees. After reviewing our staffing and business needs, we are providing this notice at the earliest possible time.
