Dear Members of the Dislocated Worker Unit:

The YMCA of the Fox Cities has temporarily laid off a large percentage of its workforce at the locations listed below in response to the COVID-19 pandemic and temporary closures mandated by Wisconsin legislatures. The YMCA of the Fox Cities does not qualify for most of the assistance provided in the various relief stimulus packages. The duration of these closures remains unknown due to the rapidly changing responses of legislatures. We are still offering childcare and school age care for essential workers and Y families.

On March 16, 2020 we notified 1394 part-time hourly (non-exempt) employees by email that they we had to close our facilities as of March 17, 2020. We informed them that we would keep them informed on when we could re-open our facilities.

On March 24, 2020 we notified 103 exempt and non-exempt employees via branch meeting and letter that they were being temporarily laid off as of March 30, 2020.

On April 7, 2020 we notified 49 full-time exempt staff via phone call and letter that they will be temporary laid off as of April 13, 2020.

As responses to the pandemic continue to rapidly evolve, so shall our response with regard to staffing. Regardless of the response, the YMCA of the Fox Cities will ensure that staff who are temporarily off duty are kept up to date.
