Re: Notice of Potential Business Closing
(WARN and WBCML Act Notice)

Dear Disclosed Worker Unit and Mr. Woodward:

This notice is provided pursuant to the Wisconsin Business Closing and Mass Layoff Law, Wis. Stat. § 109.07 (“WBCML”) and the Worker Adjustment and Retraining Notification Act, 29 U.S.C. §§ 2101 *et seq.* (“WARN”).

Marquis Yachts (the “Company”) anticipates temporarily laying off up to 117 employees currently employed at its facility located at 790 Markham Drive, Pulaski, Wisconsin. The layoffs will begin June 26, 2020, and will continue through August 15, 2020, as follows: 65 employees will be laid off on June 26, 2020, or within 14 days after that date; 35 employees will be laid off on July 10, 2020, or within 14 days after that date; 17 employees will be laid off on August 1, 2020, or within 14 days after that date. Notice was sent to all affected employees on April 21, 2020.

These layoffs are the result of changing business needs due to the COVID-19 pandemic. The layoffs are expected to be temporary, but we do not have an anticipated return date at this time. This notice is based on information currently available to the Company, and will be updated if necessary in light of new information.

The affected employees at this location are not represented by any union, and there are no bumping rights for employees affected by this closure. Attached is a list of the job titles and number of employees currently holding the affected jobs.
