**RE: Sam Van Galder, Inc.
(Notice of Mass Layoffs Pursuant to WBCML and WARN Act)**

To Whom It May Concern:

This letter will serve as written notice pursuant to the Worker Adjustment and Retraining Notification Act (WARN), 29 U.S.C. §2101 et seq., and the Wisconsin's Business Closing and Mass Layoff (WBCML) (Wisconsin Statutes § 109.07 and Chapter DWD 279 of the Wisconsin Administrative Code), that Sam Van Galder, Inc. (Company"), located at 715 South Pearl Street, Janesville, WI 53548, has had to rapidly cease and/or substantially reduce its operations as a direct result of the COVID-19 pandemic. Specifically, public health concerns, government issued Stay at Home Orders, school closures, and other actions taken in order to help prevent or mitigate the effects of the COVID-19 pandemic have negatively impacted travel and overall business operations. These unforeseen business circumstances caused by the COVID-19 pandemic have forced the Company to implement a mass layoff without the ability to provide its employees advanced notice. The mass layoff was caused by COVID-19-related business circumstances that were not reasonably foreseeable at the time that notice would have been required under WARN and the WBCML.

The Company expects the layoffs to be temporary. However, due to the unprecedented nature of the pandemic, the Company cannot guarantee any timeline for recall. Employee layoffs commenced on March 14, 2020. Additional layoffs occurred on March 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 30, 31, April 3, 4 and 8th. No additional layoffs are anticipated at this time. A list of job titles of positions that have been affected, and the number of employees laid off in each job classification is enclosed on Exhibit A.

Bargaining unit employees who have been furloughed are represented by Teamsters Local Union No. 695. The chief elected union official is Business Agent Brian Troha, 1314 N. Stoughton Rd., Madison, WI 53714, (608) 244-6207.

None of the bargaining unit employees who have been furloughed are entitled to exercise displacement or bumping rights under the terms of the collective bargaining agreement between Sam Van Galder, Inc. and Teamsters Local Union No. 695. There are no "bumping" or displacement rights for affected non-union employees.
