To Whom It May Concern:

Federal and State Worker Adjustment and Retraining Notification ("WARN") laws require that we provide you with certain information as a precaution. This letter is provided in compliance with WARN to inform you that, as a result of unforeseen business circumstances resulting from the sudden and unprecedented effects of the Coronavirus (COVID-19) outbreak on our business, Bed Bath & Beyond is conducting temporary furloughs at certain stores. Attachment A to this letter indicates stores subject to WARN notifications, whether the entire store is closed or whether it is a partial closure, the number of employees affected by the furlough at the store, and the dates that furloughs are being initiated. The affected employees at the listed stores are not represented by a union, and there are not bumping rights for affected employees. At this time and based on the information currently available, we anticipate that the furloughs will be temporary.

We apologize that we were unable to provide more advance notice of the action. We are providing this notice as soon as possible in light of the rapidly-developing events surrounding COVID-19, which is now recognized as a global pandemic, natural disaster, and physical calamity. There are numerous government and health directives impacting our business and making it impossible to continue operations for the time being. The speed and vast impact of the coronavirus outbreak has been unprecedented. After reviewing our staffing and business needs, we are providing this notice at the earliest possible time.
