Re: Notice of Temporary Furlough in Response to COVID-19

Dear Sir/Madam:

This letter is notice that, due to the COVID-19 pandemic, Foot Locker Retail, Inc. is placing part-time employees who work at Foot Locker Retail, Inc. stores on temporary, unpaid furloughs.

The affected stores and employees are listed in the attached Exhibit A. The furlough commenced on April 26, 2020. Such furlough is intended to be temporary, last less than six months, and does not affect the entire worksites. The furloughed employees are considered active employees and there will be no break in employment. There is currently no anticipation of additional furloughs at these sites.

Although we do not believe that this action triggers the requirements of the federal or state Worker Adjustment and Retraining Notification Act, we thought it appropriate to give you this notice. We are taking these employment actions because of COVID-19-related business circumstances that were not reasonably foreseeable. We would like to have given more notice of this action, but were unable to do so because of how quickly our operations were affected by the COVID-19 pandemic, and other related international, national, state, and local governmental announcements and actions. In addition, until very recently, we were hoping the circumstances would have enabled us to reopen sooner. We are providing as much notice as is practicable under these circumstances and given the rapid pace at which this situation has developed.

We also have given appropriate notice to the affected workers. The furloughed employees are non-union employees and bumping rights do not exist.
