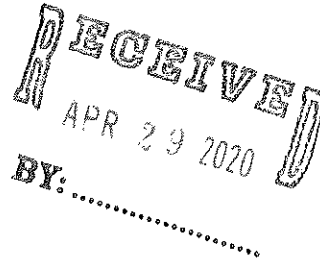

This correspondence is being forwarded in an abundance of caution.

As a result of a series of unforeseen local governmental shutdown orders and federal and CDC guidance recommending social distancing surrounding the coronavirus natural disaster, Enterprise Holdings ("Enterprise" or the "Company") experienced a dramatic downturn in business resulting in the decision to place many employees at Enterprise Rent-A-Car Company of Wisconsin, LLC located at S17W22650 LINCOLN AVE, WAUKESHA, WI 53186 on temporary layoff effective March 23, 2020. This layoff was and still is expected to be temporary.

At the time these temporary layoffs were announced, the Company did not believe there was a reasonable probability that the layoffs would last more than six months; indeed, it was the Company's belief that the layoffs would be for a relatively short duration.
