Bluegreen Vacations Corporation (the Company) maintains facilities at S-944 and S-947 Christmas Mountain Road, Wisconsin Dells, Wisconsin 53965; and at 1701 Wisconsin Dells Pkwy, Lake Delton, WI 53940. Changing business needs and circumstances relating to the COVID-19 pandemic require us to temporarily reduce the size of the Company's workforce at these locations. Temporary furloughs began on March 27 and April 13, 2020. There are no applicable bumping rights. Employees will be temporarily furloughed by location as follows:

We would like to have given more notice of this action, but were unable to do so because of how quickly our operations were affected by the COVID-19 pandemic, the World Health Organization's

pandemic declaration on March 11th, the President's declaration of a national emergency on March 13th, and other related governmental announcements and actions.
