To whom it may concern,

Covia Holdings Corporation has conducted layoffs at the following facility:

 Covia Corporation, Tunnel City, WI 20319 State Hwy 21 Tomah, WI 54660

These layoffs have been prompted by organizational restructuring and a reduction in business operations. Unfortunately, we are unsure of the duration of this layoff and it may be permanent.

These actions have resulted in the layoff of a total of 32 employees. All affected employees are being notified of their eligibility to receive continued pay and benefits for 60 days. Covia also is providing notice to state and local government officials, in accordance with applicable law and contemporaneous with this letter. Attached is census data which will show the effective date of the reductions.

All employees will be paid all wages and benefits required by applicable law. Such wages and benefits will be paid in accordance with regular payroll practices.
