Dear Members of the Dislocated Worker Unit:

Humane Manufacturing, LLC is a company of over 50 employees (Janesville and Baraboo). Humane Manufacturing, LLC will be permanently closing its facility at 805 Moore Street | Baraboo, WI 53913. The closure has been prompted by the company’s decision to consolidate the two location into one location. This action is expected to result in the permanent elimination of 21 hourly positions.

On Thursday, February 13<sup>th</sup>, twenty-seven Baraboo employees were notified that Humane Manufacturing will be permanently closing its Baraboo location at:
