RE: Notice of Mass Layoff

Dear Members of the Dislocated Worker Unit and Mayor Barrett:

Derse Inc. is notifying you that due to the unanticipated and unforeseeable circumstances associated with the COVID-19 pandemic, the trade show industry that we are part of has been entirely decimated with every show in the country cancelled or postponed, and therefore we are forced to lay off a significant portion of our workforce at our location at 3800 W. Canal St., Milwaukee, WI 53208.

While we hope that many of these layoffs are temporary, it is solely dependent on when in-person trade shows resume. Because the time frame for this is still unknown, we felt it prudent to notify you and our employees that some of these layoffs may be longer than 6 months. In total we plan to terminate 10 people and lay off an additional 77 employees. These will take place with the majority of individuals on June 11, 2020 and the additional on or around June 19th, June 30th, and July 15, 2020. Approximately 26 of the individuals are represented by the International United Painters and Allied Trades Union. While there are some bumping rights within the CBA, at this time all union personnel will be subject to the layoff. The representative of this union is Dean Wanty, Business Representative of Local 770. Mr. Wanty is located at P.O. Box 189 Big Bend, WI 53103 and he will be notified appropriately.

Attached is a list of job titles and number affected within in each job title. The company will ensure that employees will be paid all earned wages and agreed upon benefits at the time of their layoff or termination. While we wish we could have given additional notice, the unforeseen business circumstances surrounding this pandemic has made this entire situation impossible to plan for or predict in anyway.
