RE: Delmonico's of Madison, LLC / Temporary Closure and Layoff Notice

Dear Dislocated Worker Unit,

The purpose of this letter is to confirm that Delmonico's of Madison, LLC, dba Johnny Delmonico's, is temporarily closing its business and laying off all or most of its staff at its restaurant facilities at 130 S. Pinckney St., in Madison, Wisconsin, in response to unforeseen business circumstances stemming from the global COVID-19 pandemic and the continued local emergency orders and guidelines relating to the global pandemic. As a result of this closure and these layoffs, employee terminations will be effective October 30, 2020 and will affect 21 employees. Due to these unforeseen business circumstances, we could not provide earlier notice of this closure and these layoffs.

We anticipate that the business closing will be temporary and that we will be able to rehire some or most employees, but the duration is presently unknown and depends, in part, on how long applicable government restrictions and guidelines on assemblies in places of public accommodation remain in place. Our primary concern is with the safety and health of our employees, guests, and the general public.

Enclosed is a list of affected employment positions and the number of affected employees in each affected position. The employees do not have any bumping rights. The Company will ensure that employees are timely paid all wages earned through the date of the layoff.

Please let me know if there is anything we can do to assist the Department of Workforce Development, its Workforce Development Board, or the City to share information with our employees concerning any federal, state, or local government benefits or resources that may be available to them under the circumstances.

By providing this notice, Delmonico's of Madison, LLC and Food Fight Restaurant Group are not conceding or admitting that this notice was required under Wisconsin or Federal law.
