In compliance with the Worker Adjustment and Retraining Notification Act (WARN), this letter is to advise you that Eau Claire Anesthesiologists, Ltd. ("ECA") plans to permanently close its business, which is located at 1101 W Clairemont Ave # 2C, Eau Claire, WI 54701. All 54 employees will be separated from employment effective December 31, 2020.


This letter shall serve as ECA's notice of layoffs and plant closing to the Department and to the local chief elected officials identified below, and is intended to satisfy any notice requirements.
