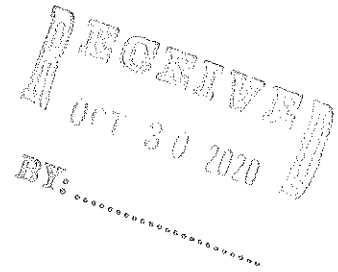

Re: Business Closing

This letter serves as the required notice of a business closing made pursuant to Wisconsin's Business Closing and Mass Layoff Law (Wis. Stat. §§109.07).

Please be advised that School Sisters of Notre Dame Central Pacific Province, Inc. (the "Company") is undertaking a business closing at its facility located at 13105 Watertown Plank Road, Elm Grove, Wisconsin 53122, which will occur on December 31, 2020. The expected date that all employees will be terminated is December 31, 2020. Affected employees will be paid any earned wages in accordance with applicable law. Please note, however, that most of the Company's employees will be rehired by Milwaukee Catholic Home to provide the same services at the Elm Grove site.

The business closing will affect approximately 66 employees. At the present time, it is expected that the business closing will be permanent. In connection with the business closing, the affected facility will be completely closed.

In accordance with Company policy, the employees affected by the business closing have no automatic transfer or bumping rights to another facility. The affected employees do not have a collective bargaining representative.

Each individual employee affected by the business closing is concurrently receiving proper notification of the business closing, including the anticipated date his or her employment will end. Attached is a list of the job titles of the positions affected by the business closing and the number of affected employees in each job classification.
