Dear Sir or Madam,

On October 28, 2020, Calibre, Inc. (Calibre) sent you a Notice of Business/Plant Closing pursuant to the Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. (WARN Act), and the Wisconsin Business Closing and Mass Layoff law, Wis. Stat. § 109.07 (WBCL). In that letter, Calibre stated that it would be permanently closing its facilities located at 2395 Dakota Drive, Grafton, WI 53024; 1889 HWY W, Grafton, WI 53024; 651 Dekora Woods Blvd., Saukville, WI 53080; and 655 Dekora Woods Blvd., Saukville, WI 53080; that such closure would begin on December 31, 2020; that Calibre would be closing in its entirety on August 31, 2021; and that 204 employees would be affected by this closing. These facts, as outlined in the October 28, 2020 notice, remain true.

However, upon further evaluation of its business needs, Calibre has revised some of the termination dates. A list of job titles that will be affected and the number of affected employees in each position, as well as their updated proposed termination dates, is included as **Exhibit A** to this letter. The affected employees are not represented by a union and do not have any bumping rights. The information provided in this letter is based upon the best information available to Calibre at this time. This letter is provided pursuant to the WARN Act and the WBCL. This letter should not be construed as an admission of coverage under WARN or the WBCL or that Calibre is required to comply with the plant or business closing notice statutes, but rather, this letter is provided pursuant

to state and federal laws that encourage employers to provide notices of anticipated business or plant closings.
