Re: Updated Notice of Business Closing and Layoffs

Dear Members of the Dislocated Workers Unit:

Nova Wildcat Shur-Line, LLC ("Shur-Line" or the "Company") will now be permanently closing its entire manufacturing operations at its Shur-Line facility located at 4051 South Iowa Avenue, St. Francis, WI 53235 (the "Facility"), effective on or about February 28, 2021. In connection with these plans, the Company expects that the employment of 14 employees working at the Facility will cease and the next 5 layoffs and/or employment separations will take place on or about February 12, 2021, or during the 14-day period beginning on that date. In addition, the Company expects 7 layoffs and/or employment separations will take place on or about February 15, 2021, or during the 14-day period beginning on that date. Finally, the Company also expects 2 layoffs and/or employment separations will take place on or about March 26, 2021, or during the 14-day period beginning on that date.
