Re: Notice of Permanent Business Closure
(WARN and WBCML Act Notice)

Dear Dislocated Worker Unit and Mr. Woodward:

This notice is provided pursuant to the Wisconsin Business Closing and Mass Layoff Law, Wis. Stat. § 109.07 (“WBCML”) and the Worker Adjustment and Retraining Notification Act, 29 U.S.C. §§ 2101 *et seq.* (“WARN”). This notice is an update to prior notices provided to you on January 28, 2020, April 21, 2020, July 16, 2020 and August 4, 2020.

As stated in our January 28, 2020 notice, Marquis Yachts (the “Company”) was then in the process of negotiating a sale of the Company. The Company has now signed a purchase agreement to sell the Company’s real estate, fixtures to real estate and ancillary personal property located at 700 E. Glenbrook Drive, Pulaski, Wisconsin. The Company and the proposed purchaser are negotiating the final terms of that agreement.

Therefore, we are providing this notice of permanent closure of the Marquis Yachts facility located at 700 E. Glenbrook Drive, Pulaski, Wisconsin, effective approximately July 30, 2021, or when the final boat is manufactured and/or repaired, whichever occurs later. This closure will impact all 77 employees at the Pulaski facility, and layoffs will be conducted on a rolling basis based on the work that remains to be done at any given time. Impacted employees were provided notice of this closure and of their termination date on March 5, 2021.

Notably, the proposed purchaser has expressed its desire to create new employment opportunities for Marquis Yachts current employees.

The affected employees at this location are not represented by any union, and there are no bumping rights for employees affected by this closure. Attached is a list of the job titles and number of employees currently holding the affected jobs, along with the respective anticipated layoff dates.
