Re: Notice of Scheduled Action – Foot Locker Corporate Services, Inc.

Dear Sir/Madam:

In compliance with the Worker Adjustment and Retraining Notification (WARN) Act and the Wisconsin Business Closing and Mass Layoff Law, we are writing to provide notice that Foot Locker Corporate Services, Inc. has identified opportunities to elevate our digital capabilities to build deeper connections with our customers across our family of brands. As a result, we have had to make the difficult but necessary decision to partner with a third-party service for some of our IT operational functions based on business need, resulting in eliminations of certain existing roles at our Milwaukee location at 7800 W Brown Deer Road, Milwaukee, WI 53223, beginning on May 30, 2021.

There will be a total of 22 employees affected by this planned action at the employment site. The first employment action is scheduled to occur on May 30, 2021, and the second employment action is scheduled for June 29, 2021. This employment action is expected to be permanent and does not affect the entire worksite. There is currently no anticipation of additional layoffs as part of this WARN event.

We have provided the appropriate notice to the affected workers, including the contact information for the local workforce development board serving their worksite area. The affected workers are non-union employees and bumping rights do not exist. Please see the attached

Exhibit A containing the job titles of positions to be affected and the number of affected employees in each job classification.
