Re: Worker Adjustment and Retraining Notification Act (WARN) Notice of Layoff at Hufcor Inc. – 2101 Kennedy Road, Janesville, Wisconsin 53545

Dear Government Officials:

This letter is notice that Hufcor Inc. ("Hufcor" or the "Company") is implementing a reduction in force and ceasing manufacturing operations/production at the Company's facility located at 2101 Kennedy Road, Janesville, Wisconsin 53545. As a consequence, a total of 166 employees at that location will be involuntarily terminated.

While no exact date of discontinuance of manufacturing/production operations has been established, the Company expects that the first layoffs related to the facility will commence on Tuesday, August 3, 2021 (or within the 14-day period following that date). The terminations are expected to be permanent, but the facility will remain open for limited, non-production work.

There are 156 employees who will be discharged who are represented by IUE-CWA, the Industrial Division of the Communications Workers of America ("CWA"), AFL-CIO on behalf of itself and its Local 84811 (the "Union"). Bumping rights for affected Union-represented employees would be governed by the applicable collective bargaining agreement. The Union has been informed of these plans. There are an additional 10 employees who will be discharged who are not represented by a union. These employees have no bumping rights.
