Re Announcement of Planned Action

Dear Bureau of Workforce Training:

We are writing to give you notice that there will be a total closure of the GXO Logistics Supply Chain, Inc. facility located at 901 Renaissance Blvd., Sturtevant, WI 53177 (the "facility"). The entire facility will be closed and all employees at the facility will be impacted. This closure is expected to be permanent. The expected date of the first separation will be September 10, 2022.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Attached is a list of the job positions and number of individuals who will be affected by the closure along with the anticipated schedule for job losses. There are 144 employees impacted by the closure. There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of this closure. There is no union representing affected employees.
