Re      Announcement of Planned Action

Dear Bureau of Workforce Training:

This letter updates our letter of July 11, 2022 (copy attached) in which we notified you that there will be a total closure of the GXO Logistics Supply Chain, Inc. facility located at 901 Renaissance Blvd., Sturtevant, WI 53177 (the "facility"). Since our July 11, 2022 notification, the facility has notified two additional employees that their employment will be impacted by the closure, bringing the total number of employees impacted by the closure to 146. The attached chart has been updated to reflect this change. The entire facility will be closed and all employees at the facility will be impacted. This closure is expected to be permanent. The expected date of the first separation will be September 10, 2022. There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of this closure. There is no union representing affected employees.
