Re: Notice of Business Closing – Inlanta Mortgage, Inc.

Dear Sir or Madame:

Due to the dramatic and unanticipated drop in mortgage product demand, business circumstances have dictated that Inlanta Mortgage's assets be transitioned to a third-party purchaser. The affected employment site based at W239N3490 Pewaukee Rd, Pewaukee, WI 53072. This action is expected to result in the permanent elimination of 62 employees. It is expected to commence on November 29, 2022, and to proceed until completion of wind-down in early April 2023. This is contingent upon finalization of the transaction and other wind-down considerations.

As this action has been caused by unforeseeable business conditions, this notice has been provided compliant with WARN Act obligations at the earliest possible opportunity. The employees are not represented by a labor union or collective bargaining agreement. No bumping rights exist.

Attached is the anticipated schedule of affected positions, which includes expected layoff schedule, job titles affected, and number of affected employees per job title. See separate schedule below.
