Re: Updated Announcement of Planned Action

Dear Bureau:

We are writing to inform you that GXO Logistics Supply Chain, Inc. will cease all operations at the facility located at 10375 140th Avenue, Kenosha, WI 53142 (the "facility") no later than February 13, 2023. All GXO employees at the facility will be impacted, and GXO's cessation of operations at the facility is expected to be permanent. The expected date of the earliest GXO employee separations as a result of this planned action is February 13, 2023.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Those employees are expected to be separated from employment beginning on February 13, 2023, with all separations accomplished within a 14-day window of that date.

The attached is a list of the job positions and number of individuals who will be affected by the closure along with the anticipated schedule for job losses. There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of this closure. There is no union representing affected employees.
