Re: Notice of Layoff

Dear Dislocated Workers Unit:

Superior Die Set Corp. ("SDSC") regrets to inform you that it will implement a plant closing of its facility in Oak Creek, Wisconsin, at 900 West Drexel Avenue, as a result of decreasing volume of orders and the liquidation of the business. We expect the layoffs to occur on **November 20, 2023**, or within 14 days of this date. 133 employees will be affected. The employment losses are expected to be permanent. We have notified the affected workers today by letter of their layoff. We are also notifying today each affected employees' collective bargaining representative and the local elected officials serving Oak Creek, Wisconsin.

While we expect there to be a plant closing on November 20, 2023, there remains a possibility there may be a buyer and operations would continue. There is work to be done between now and November 20th regardless of future events and we appreciate everyone's continued focus.



Attached is a list of job titles of positions to be affected, and the number of affected employees in each job category.

While bumping rights exist under the labor agreement, all bargaining unit employees will be laid off. The name and address of the collective bargaining representative is Hunter Scott, District 10, IAMAW, 107 Warren Street, Suite 2, Beaver Dam, Wisconsin 53916.
