Re: Notice of Business Closing

Dear Members of the Dislocated Worker Unit:

This notice is being provided to you pursuant to the Worker Adjustment and Retraining Notification Act of 1988, 29 USC §2101, et. seq. and Wisconsin's Business Closing and Mass Layoff Law, Wis. Stat. § 109.07, both of which require employers to give notice of a pending business closure.

HSHS hospitals and clinics in Western Wisconsin are permanently closing. Prevea Clinic, Inc. provides staffing to the HSHS hospitals and clinics in Western Wisconsin. Due to the permanent closing of the entire employment site at each location set forth in Attachments A through P, at this time, Prevea Clinic, Inc. expects that it will be permanently terminating a total of 323 employees. Separations are anticipated to begin on March 22, 2024.

In addition to the name and address of the employment site, each attachment contains a listing of all job titles at each site, the number of affected employees for each job title, and the anticipated separation schedule for employees at the site.

No employees are represented by a union and no bumping rights exist for these employees.
