SUBJECT: AMENDED Notice of Facility Closure / WARN Act Notice

Dear Members of the Dislocated Workers Unit:

This is to inform you on August 3, 2024, Goodwill Manufacturing, Inc., (“Company”) will permanently close its Laundry and Linen Services facility, located at 6055 N. 91st Street Milwaukee, WI 53225. This action is expected to result in the permanent separation of 136 employees.


Enclosed is a listing of the job titles of the positions to be affected and the number of affected employees in each job classification. The employee separations will begin August 3, 2024, depending on individual employee work schedules. Each employee impacted will receive a written 60-day notice of position elimination and will be paid all earned wages and agreed upon benefits at the time of their termination. Additional information required by 29 C.F.R. § 639.7(e) is available upon request.

Certain affected employees of the Transportation Department are represented by Service Employees International Union (SEIU), Wisconsin. The chief elected officers of the union are Pat Raes, President; Louis Davis, Executive Director; and David Somerscales, Union Representative; located at Eastern Wisconsin Office, 633 S. Hawley Road, Suite 106, Milwaukee, WI 53214. Pursuant to the current collective bargaining agreement, **Union members shall have “bumping rights”** that would allow an employee to bump or displace another employee working for the Company, based upon their length of tenure with the Company.

To the extent that the above actions constitute a covered event under the Worker Adjustment and Retraining Notification Act (WARN), and any corresponding state or local law, this letter is intended to fulfill any requirements imposed under those laws.
