To Whom it May Concern:

Under the terms of the 60 days advance notice requirements for the State of Wisconsin Business Closing and Mass Layoff Law, we are hereby formally announcing the plant closure of the Silgan Containers Manufacturing Corporation Oconomowoc facility (located at 520 W. 2<sup>nd</sup> Street). The plant currently employs a total of fifty-six (56) employees. Layoffs are estimated to begin on or after July 21, 2025, and will continue with limited production running into August 2025 or later. Volumes will be absorbed by other Silgan facilities.
