RE: McDonald Plastic Molding, Inc./Federal & State WARN Act Notice of Poynette Facility Closing

Dear State of Wisconsin Dislocated Worker Unit & Village President Kaschinske:

I regret to inform you that McDonald Plastic Molding, Inc. ("MPM") is permanently closing its facility at 650 Northern Court, Poynette, Wisconsin, due to relocation of facility operations to MPM's production facility in Darlington, Wisconsin. The Poynette facility closing will be effective on or before December 31, 2025, and affect twenty-eight employees. Twenty-eight of these employees have been invited to apply for open positions in its Cuba City, Darlington, and Monroe facilities.

Employees who are not selected for an opening in another facility can expect to be permanently separated from employment between June 27 and December 31, 2025. Enclosed is a list of affected job titles, the number of Poynette employees in those job titles, and their anticipated separation date(s). The employees are non-union and do not have any bumping rights. MPM will ensure that employees are timely paid all wages earned through the date of separation.

MPM is informing its employees that the Wisconsin Department of Workforce Development ("DWD") and its Workforce Development Board ("WDB") work together in an effort to assist employees affected by facility closings and layoffs. If you have any additional information you would like MPM to share with affected employees, please let me know. If you have any questions or require any additional information, please let us know.
