Re: Notice of Workforce Reduction (WARN)

To Whom It May Concern:

BRP US Inc. ("**BRP US**") is writing to provide you with notice of a mass layoff at its Sturtevant, Wisconsin facility located at 10101 Science Dr, Sturtevant, WI 53177. This notice is provided in accordance with the Wisconsin Business Closing and Mass Layoff Law, Wis. Stat. § 109.07 ("**WBCL**") and the Federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. §§ 2101-2109 ("**WARN**").

At this time, the layoff will be affecting a total of 61 individuals employed by BRP US at its Sturtevant facility, including new and low-hour employees. Layoffs will begin today, June 5, 2025, with 39 employees being immediately affected. The remaining 22 impacted employees will be gradually laid off in the coming weeks according to our operational needs. All the layoffs will be permanent, and all impacted employees will receive pay in lieu of notice. Exhibit A attached provides the list of the job titles of positions that are impacted and the number of impacted employees in each job category.

As of today, BRP has notified all employees who are entitled to notice under the WBCL and WARN concerning these job eliminations. None of the employees are represented by a union and there are no bumping rights associated with any of the positions.
