Re: Notice of Germantown Plant Closure

Pursuant to Wis. Stat. Section 109.07 and the Worker Adjustment and Retraining Notification Act of 1988, 29 U.S.C. 2101 et seq. ("WARN Act"), Pregis Innovative Packaging, LLC (the "Company") is providing formal notice that it will be permanently closing its entire facility located at N102 W19300 Willow Creek Way, Germantown, WI 53022 ("Germantown Plant"). All separations are expected to be permanent.

The closing of the Germantown Plant will result in permanent employment separation for all 48 employees employed at the Germantown Plant and affect both salaried and hourly workers. There is no union representing affected employees.

The Company anticipates the facility closure will occur on or about April 30th, 2026. All employee separations will take place on or before April 30th, 2026.

The job titles of the positions that are affected, together with the number of employees in each classification, are set forth in <u>Attachment A</u>. All separating employees are being provided an appropriate notice of their separation date and advised that their separation from the Company will be permanent.

There will not be any bumping rights for affected employees – that is, employees will not be able to displace more junior employees out of their job positions because of this closure.
