Re: Announcement of Facility Closure

To Whom it May Concern:

We are writing to give you notice that there will be a total closure of the Tekni-Plex facility located at 6161 N 64th Street in Milwaukee, Wisconsin on April 30, 2026. The entire facility will be closed and all employees at the facility will be affected. This closure is expected to be permanent. The expected date of the first separation will be March 27, 2026.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Affected employees are expected to be separated from employment beginning on March 27, 2026, with all separations accomplished by April 30, 2026.

Attached is a list of the job positions and number of individuals who will be affected by the plant closing along with the anticipated schedule for job losses.

There are potentially some bumping rights for some affected employees; that is, more senior employees on third shift may potentially be able to displace more junior employees out of their job positions as a result of this closure, meaning the more junior employees who are bumped would be terminated and be eligible for severance as of March 27, 2026.

We have notified Richard Shorter, the chief elected official of the International Union of Electronic, Electrical, Salaried, Machine and Furniture Workers/Communication Workers of America, Local 84101 ("IUE-CWA"), of this information at the following address: 6161 N. 64th Street, Milwaukee, Wisconsin.
