Yog tus neeg tau kev pab tsis sau ib tsab ntawv qhia zaum kawg rau koj li 90 hnuv hauv hnuv koj sau koj tsab ntawv fob, koj tsis tas tos tus neeg tau kev pab sau tsab ntawv qhia ua ntej koj sau ntawv fob rau hauv CRC.

Li cas los xij, koj uav tsum sau ntawv fob rau hauv CRC li ntawm 30 hnuv ntawm 90 hnuv ntawm hnuv kawg (ib yam li, ntawm 120 hnuv tom qab hnuv koj tau sau ntawv fob nrog tus neeg tau kev pab).
